- Common and continuous sales transactions of our affiliates Trakya Cam Sanayii A.Ş and Trakya Polatlı Cam Sanayii A.Ş. within the financial year, were expected to exceed 10 % of the cost of goods sold and sales revenue figures stated in the latest publicly disclosed annual financial statements of our company. Therefore, it was decided that the pricing of Trakya Yenişehir Cam Sanayii A.Ş. and Trakya Polatlı Cam Sanayii A.Ş' sales, executed through Trakya Cam Sanayi A.Ş., would be the same with the price determined for the executed through non-related third parties, that a reasonable market-rate commissions would be charged for the services rendered, and that all terms of the transactions would be in compliance with the previous years' terms and reasonable compared with the market conditions
- Common and continuous sales of Türkiye Şişe Cam Fabrikaları A.Ş, executed through our non-public affiliate Şişecam Dış Ticaret A.Ş. within the financial year, were expected to exceed 10 % of the cost of goods sold and sales revenue figures stated in the latest publicly disclosed annual financial statements of our company. Therefore, it was decided that the pricing of Türkiye Şişecam Sanayii A.Ş.' export sales, executed through Şişecam Dış Ticaret A.Ş., would be the same with the price determined for the exports executed through non-related third parties, that a reasonable market-rate commissions would be charged for the services rendered, and that all terms of the transactions would be in compliance with the previous years' terms and reasonable compared with the market conditions.
- It was foreseen that the total amount of purchases expected to be made from our affiliates Soda Sanayii A.Ş., would exceed 10 % of the cost of goods sold figure stated in the latest publicly disclosed annual financial statements of Türkiye Şişe ve Cam Fabrikaları A.Ş. Accordingly, pricing of these common and continuous purchases from related parties will be determined within the framework of the regulations on transfer pricing and in compliance with previous years' terms and market conditions.
